### Report of the UGC NET coaching Programme 2013 - 2014

The coaching class for UGC-NET and CSIR-NET was conducted during July to October 2013 by the UGC NET coaching centre. The objective of the programme was to make the SC, ST, OBC and minority students competent enough to appear in UGC NET examinations conducted by UGC. About 123 students participated in this programme. It is noticeable that girl student participation was higher than boys. The students were taught subjects on Paper – I of UGC NET, and Section – A of Paper – I of CSIR NET. The program was conducted by an expert panel of teachers consisting of 10 highly qualified individuals in the field of teaching. The coaching programme was so designed that all the subjects were explained with adequate examples and previous year questions were also discussed by the resource persons. All the students were provided with all required work sheets and hand outs. The students were encouraged to apply for NET examinations.

It is noteworthy to mention that a book with ISBN was brought out by the UGC NET coaching centre in this year. The faculty members involved in the coaching programme contributed to this book entitled UGC NET Paper – I published by V.H.N. Senthikumara Nadar College (Autonomous), Virudhunagar.


