MINUTES OF THE ELEVENTH ACADEMIC COUNCIL MEETING

The eleventh Academic Council Meeting of Virudhunagar Hindu Nadars' Senthikumara Nadar College (Autonomous) Virudhunagar was held on 18.10.2019 at 11.30 a.m. in K.C.S.Rathinasamy Nadar - R.Mariammal Memorial Building.

The Chairperson and Principal welcomed the gathering.

The Chairperson introduced Dr. C. Karunakaran, Head, Department of Chemistry, Ms. B. Salocia Fernando, Head, Department of Botany, Dr. B. Ravichandran, Head, Department of Commerce, Mr. G. Other matters

Dr. B. Pavala kumar, Administrator – HTEL of the college, suggested that extra credits may be awarded to students who successfully complete SWAYAM online courses. Further he recommended that extra credits of 2,3,4 and 6 may be awarded to students who complete SWAYAM online courses with the duration of 4,6,8 and 12 weeks and above respectively. Dr. T. Kathirvalavakumar, Head of the Department of Computer Science proposed that SWAYAM online courses conducted for 12 weeks and above may be awarded 5 credits since the Self-learning courses conducted for the same duration in the college are awarded only 5 credits. However, it was finally resolved to follow the guidelines of SWAYAM with regard to the award of extra credits.

Subject 10:

Approval for the award of extra credit to students who complete successfully Swayam online courses.












All the ten resolutions were unanimously passed.















Out of 38 members, 32 turned out for the meeting and 6 members got permission to absent.
