The Chairperson and Principal welcomed the gathering.

If any student is unable to write the examination on the stipulated date due to health issues or unavoidable reasons, the supplementary test will be conducted. The student can write the exam from home.

All the Nine resolutions were unanimously passed.

Out of 38 members, 34 turned out for the meeting and 4 members got permission to be absent.

REPORT ON THE SUMMATIVE EXAMINATIONS, NOVEMBER 2019

A report on the Summative Examinations under the Autonomy Stream, held in the month of November 2019, is submitted to the Principal.

Pre – Exam Preparations

A total number of 611 questions were used in this summative examination, November 2019, of which we have used 350 current examination question papers & 261 questions for arrear examination. Question papers were set by 206 examiners. We are happy to inform that almost all the teachers who were offered the question setting accepted gladly and completed the assignment within the timeframe. The Question Paper setters were given a pre-structured feedback form to give their feedback on the curriculum and the subject. 129 setters have given their feedback. The feedbacks from the Question Paper setters were also sent to the respective departments for consideration and for necessary changes in curriculum. 422 questions were received by email as a go green initiative. Receiving of Question Papers by email improved the quality of Question Papers and also saved time.

Examinations

The Summative Examinations commenced on November 1, 2019 and ended on November 27, 2019. A total number of 3927 students of U.G, P.G, Certificate Course and PG Diploma Courses appeared for the examinations. During the course of examinations, a total number of 162 students (433 scripts) were absent in the 44 sessions of the examinations. We regret to inform that 11 students indulged in malpractices during the examinations. The list of students indulged in malpractices and the absentees list are enclosed.

A total number of 25,211 answer scripts (20,877 current exams, 1,052 arrear exams and 2,357 practical exams, 925 OMR scripts) were evaluated. Answer scripts of eleven students, who indulged in malpractices, were not valued and their results were withheld. In total 23,316 scripts out of 25,211 scripts passed the examinations. The overall pass percentage is 92.48%. 151 private students applied for the examinations and 75 students passed out.

We are proud to place on record that we have conducted all the semester examination's theory papers using OMR (Optical Mark Recognition) statements. We have also used OMR foil cards for our practical examinations (both internal & external). The usage of OMR machine in our Controller of Examinations office was very helpful in bringing out the results in a more effective manner and in a short duration.

All the answer scripts were given OMR which is torn on the same day of examination by a team of dedicated teachers, which enabled us to expedite the valuations. We place on record our sincere thanks and gratitude to our College staff members involved in this task.

Evaluation

A total number of 129 external examiners were appointed to carry out the evaluation work. The examiners were from Thoothukudi, Madurai, Thirumangalam, Sivagangai, Rajapalayam, Melur, Sivakasi, Sattur, Aruppukottai and Virudhunagar. The Central Valuation was started on November 7, 2019 and was completed on 27 November, 2019 (18 days). The OMR mark entries in the answer scripts were verified by our teachers, which helped for effective valuation. We sincerely thank the services of 16 staff members of our college for acting as flying squad to make surprise visit and to check the students in the examination halls. Ten Students (11 scripts) applied for photocopy of answer scripts and 64 students (67 scripts) applied for revaluation. 21 scripts were declared as pass in the revaluation. The external examiners were given a pre-structured questionnaire to get their feedback. The following are some of the important suggestions given by the examiners:

1. Most of the students do not specify the question numbers and also the sub division numbers. The examiners asked us to insist the students to write the **Question Numbers & Sub Divisions correctly**.
2. UG Students must improve their study method and writing skills.
3. Students should be motivated to improve their skills of presentations.
4. Students should be insisted to attend all the questions.
5. Staff members should give equal importance to all the units.

Awards Committee Meeting was conducted on 03.12.2019 and the results were published in our College official website and also in our college apps VHNSNC on 05.12.2019. The revaluation results were published on 23.12.2019. Overall, 92.22% of UG scripts, 94.49 % of PG scripts, 82.61 % of Certificate Course scripts and 91.30 % of Diploma course scripts were declared as pass.

** The mark structure of our PG theory papers has been changed from this academic year onwards as (40 : 60, internal : external respectively). Therefore we have to provide them with a new pattern of marks and grade statement. Towards this change we have introduced rainbow colored mark statements for our I PG students.

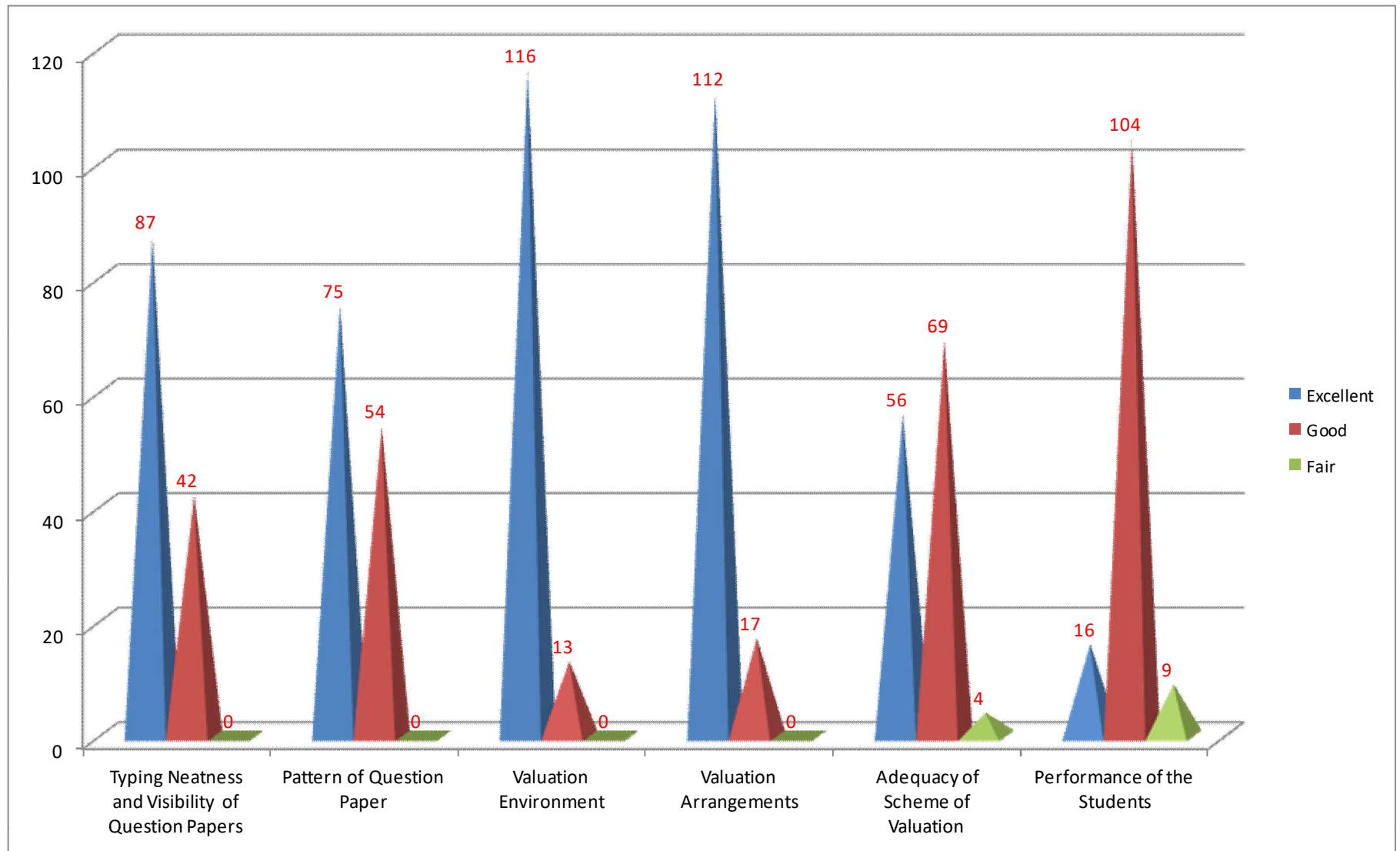
